Notes for William Audie Fowler:

• Grandpa Audie worked in the coal mines in Pitcher, Oklahoma after he married Nettie Cranford. Then they moved back to Newton County for a while. Their next move was to California for about a year. They returned to Newton County, but did live in Kansas City during WWII where Nettie worked in a parachute factory and Audie worked on planes. After the war they bought a section of land at Evansville, Arkansas and he raised cattle and sold stave bolts that he cut off

his land. He was a diabetic and eventually died from a heart attack as he was walking through his lower field after lunch one day. Nannie (Nettie) found him and ran to the neighbor's for help. He only had a fifth grade education, but had full command of the English language and math.

- Audie Fowler was an extremely intelligent man who enjoyed working with the land. He liked kitten's and shot most of his deer from the front porch of his house as they feed in his nearby garden. He liked to listen to the Grand Ole Opry on the radio at night and talk of politics and religion. He had a good sense of humor and loved to laugh. Nannie only acted aggravated when he'd talk about stealing kisses from her out behind the church when she was just a girl. She'd scold him and swear it wasn't true, but there was just enough sparkle in her eye, and a half smile that you'd have to wonder. I spent many a grand summer's with them on the farm. We had wonderful picnics in the orchard and often drove the cows on foot to Ashbee Hollow were the grazing was better. Paw Paw would ride the horse and Nannie and I would each get a long stick and off we'd go. The old dog Bulger would follow barking only occasionally. For me it was an adventure with nothing to fear, but the snakes. He and Nettie worked side-by-side and raised most of what they ate. They only bought their staples like sugar, coffee, tea, lard, and flour. Paw Paw drove an old rusted truck about 30 miles an hour. We'd often go to the cattle auction in Fayetteville and have a hot roast beef sandwich at the cafe while we were waiting for the check that his cattle would bring. When he died he had a new truck, completely paid for, parked out in front of the house.
- Nannie dried her laundry outside and canned everything out of her huge garden. Nothing will ever taste as good as her fried chicken and dinner rolls. She worked so hard all her life and always said she preferred the outside chores to being in the house. I loved the fresh smell of her ivory soaped skin and damp brow under her wide brimmed straw hat. Her lap held many a tearful child, and the leathery hands could provide all the safety that a little kid needed when the world would get a little scarry. I don't know how many times she'd call me back from my hiding place to go back home to Ft. Smith with my family after two weeks of vacation on the farm. I'd have stayed with them forever. Life will never be that simple and sweet again.
- Nettie Cranford Fowler died from kidney disease a few years after Grandpa. They were both just in their early 60's when they passed away. Everyone who knew them said, "They were the salt of the earth, and best people. They were good neighbor's and they bothered no one. They were always ready to lend a helping hand when there was a need."

Notes for Nettie Cranford:

• Uncle Clint said that Nettie and all the family worked very hard. He said that once Nettie and Oscar got into trouble with the school master and some visitors that had come to the school. They gave them a whipping. It was suppose to have Bud Cranford a pretty penny to get them out of trouble.

Notes for Clint Fowler:

- Clint was a Marine and he was stationed in China just after WWII ended. He was employed at American Airlines as a structural mechanic until he retired. He was a member of the Professional Rodeo Cowboy Association (PRCA) as a bull rider in his younger years and enjoyed roping when he got older. He was a member of the Lincoln Baptist Church. He had been a deacon at the Riverview Baptist Church in Bixby, Oklahoma. He loved to dance and was quite good at it as well.
- The loss of his beloved wife, Josephine, was hard on him but the tragic death of his son Audie Dean Fowler in a car wreck surely almost crushed his spirit. He has survived his losses and

always has a smile and interesting conversation whenever you see him. He has been a wealth of knowledge about the Fowler/Cranford family history and appeared to enjoy talking with the other members of the Fowler family that he met through the years.

- After the death of Josephine he also developed colon cancer which was removed without consequence.
- Seven years later he discovered the he had an undiagnosed melanoma behind an ear. By (February 1999) it had gone to his lungs and after an exploratory surgery he was told that there was nothing more that could be done. He told me that he wasn't afraid of death and that his life seemed to be full of misery and struggle anyway. He expected the next life might be a better one. He told me that he thought that death was hardest for those we leave behind. They seem to suffered the most. He was disappointed that the cancer had spread, but intended to live as long as he could without all the radiation and chemotherapy that he had seen destroy his wife and sister, Dorothy Dean Fowler Goldman. Those treatments wouldn't have saved him anyway. He had no kidney function and was on dialysis. He had high blood pressure and diabetes. His body was just worn out with this life. It's very difficult to face one's own mortality, but he did it with grace and dignity.
- Clint's father, Audie Fowler, was working in the coal mines in Pitcher, Oklahoma when he was born. The Irish doctor that delivered him asked Audie Fowler and Nettie "Cranford" Fowler what they were going to name their new first born child and they told him that they hadn't decided. Later they found out that the doctor wrote on the birth certificate that his name was "Patrick" Fowler. The birth certificate was never changed.
- He was buried on July 7, 1999 with Brother Vernon Fowler of Jasper, Arkansas officiating. Music was provided by his brother-in-law, Leo Feathers. Pallbearers included Leo Feathers, Eddie Fowler, Bobby Fowler, Dennis Neely, Jim Mullins, and Wayne Hughes. Honorary: Nate Holmes and John Garrett.

Notes for Josephine Ina Louise Feathers:

- Josephine Feathers (Fowler) was a blue eyed Cherokee form the Greasy community in Adair County, Oklahoma. She loved Rodeo and was a champion barrel racer. Clint rode bulls when he was young and became a roper in his later years. They raised their children, Matt. Audie, and Latonna around the Bixby, Mounds, Oklahoma area before moving back to Evansville to retire. Josephine had been married before and had two children named Danny and Jan with her first husband, Richard Jones. Clint raised them and loved them as if they were his blood children. He was always their father.
- Matt and Audie were also part of the rodeo scene. Matt was a member of the PRCA and Indian
 associations. Audie also rode bulls in the Indian Association. Both were champion bull riders in
 their own right and were well known by all Rodeo people in the state of Oklahoma and other
 places as well.
- Latonna, like her mother she had stark blue eyes and was quite beautiful.
- After Jo retired she and Clint bought the Audie Fowler home place at Evansville, Arkansas. Jo became ill with lymphoma before Clint could retire from American Airlines and died after a long struggle with the cancer. Her immune system was so compromised that pneumonia killer her in the end. She certainly did everything she could to live and Clint was at her side the entire time.

Notes for Ginger Northington:

- She had been a friend of Clint's for almost 8 years when he got his diagnosis of terminal cancer.
- ii. Conard Fowler, born 1930; died September 06, 1930 in Fayetteville City Hospital *Buried at Ryker, AR Cave Mt. Cemetery.

Notes for Conard Fowler:

- Conard died as a 6 month old infant of bronchial pneumonia. His death certificate has his name as "Conrad" and no middle name. Clint Fowler said that he could remember that the child cried a lot and that his mother would tell him to go and rock Conard's crib so she could get dinner ready. Nannie said that he just got a high fever. Although the weather was bad Grandpa Audie took the baby on to the Fayetteville City Hospital where he was pronounced dead upon arrival.
- On her death bed Nettie Cranford Fowler spoke of this child as if she could see him and as if she had gone back in time when she had this baby. He is buried in the Cave Mountain Cemetery with nothing to mark his grave but a field stone. I'm sure that she went to met this lost baby and her beloved Audie when she died. When Audie Fowler passed away she began to die herself.
- Conard died as a 7 or 8 month old infant child. On her death bed Nettie Cranford Fowler spoke of this child as if she could see him. Im' sure that she went to met this lost baby. He was born inbetween Clint and Dorothy.

Notes for Edwin Leander Fowler:

• Ed Fowler was a mule trader and singer. As a teacher he taught shaped notes and was by all accounts very musically talented as were many of the Fowlers. He chose to remain in the Arkansas hills after marrying Belle Wyatt. Ed worked in the Ozark woods as a timber boss and a skilled sharpener of crosscut saws ("misery-whips" on which loggers depended for felling the big trees, prior to the advent of chain saws near the mid-twentieth century.) His sons, Troy, Audie, Walter, Chester, and Efton were all "timber men", horse and mule loggers, stave-buckers, and tie hackers. It was hard, dangerous work.

Notes for Emily Bell Wyatt:

- Bell was a very neatly put together woman that sort of reminded me of Whistler's Mother because of the black lace that she wore on her head. There was a softness about her. Once when she'd been to visit Mintie after she'd broken a shoulder, Uncle Clint was going to take her back to Newton County and they were crossing the Arkansas River bridge at Muskogee, she told him that she remembered crossing that river in a covered wagon. They say she walked to church every Sunday and that she died quietly in her sleep.
- Bell's home is still intact and just about the way she left it. Her dresses still hang in the closet. It must have been very sad for her to have seen so many of her children die. No mother is prepared to bury her children.
- One research has that show died in Fulton County, Arkansas.

Notes for Troy Fowler:

- In 1943 Troy joined Walter Fowler in the timber business. Troy acquired an army truck to supplement his four mules in hauling timber up and down the Big Buffalo River.
- A major flood occurred in the valley in 1945. According to Dixie, "....As Troy watched the river slowly rising, he remembered the brand new truck and manure spreader sitting near the barn.....Troy, his son Bill, and three older men rushed down to the barn to try to get the vehicles moved to higher ground but it was too late.. They didn't even reach the barn before the water got too high. Then it cut them off from the house. They retreated to the highest part of the field, but he water continued to rise. Their only escape was to climb a big walnut tree. Dixie watched from the house and saw the light that they carried go up into the tree, so she knew where they were. They had to stay there until midnight (4 hours).

Notes for Dixie Carrol:

- Dixie Fowler spent most of her years living along the Buffalo River at Boxley played her five-string banjo and could play "Cripple Creek" with the best of them. As a youngster of about 5 she learned to play chords with her father, and they played duets on the fiddle and banjo and singing.

Notes for Cornelius (Neil) Cranford:

- Cornelius Cranford's father, Ambrose died in the Civil War with his brother(?) Nettie Cranford Fowler always said of her grandfather and an uncle, "One fought for the North and one fought for the South." She called her father, Neil, Pap.
- Oral family history says that Cornelius Cranford's mother, Caroline Hurley, died when he was 3 days old, and by age 7 his father, Ambrose had died in the Civil War along with an uncle and many more of his cousins. Cornelious was raised by a grandmother and was also known as "Neil or Bud" Cranford. Clint Fowler said that he didn't weigh more than 140 lbs. The Bryant's were supposed to be dark complected, with high check bones and some of the children had dark hair.
- Neil Cranford had been all over the United States before he turned 38 and got married. He traveled first to Florida and then went west where he was a cattle drover on the Chisom Trail and he even was said to have panned some gold in northern California and Canada. He had been to most of the western states and there wasn't much that he hadn't seen in that part of the country. He could give very detailed land descriptions of the places that he had been.
- It is said that in Salt Lake he had a quarrel with a Chinese cook over the way that his steak was prepared. The cook began to chase him with a knife and Neil said had he had to defend himself. He shot the man dead. After that he left Utah without much ado and just wandered for a while until he reached the Ozark Mountains in Arkansas where he met and married 18 year-old Sallie Bryant. That ended his world travels.
- Although he and Sallie raised a large family he never went to a bank to borrow money or worked out away from the home. Maybe there was for a very good reason for that, but in any case, they got by. One of the few times he went into town was to pay his yearly taxes.
- Neil and his son Lenoard had been a drinking men until Lenoard was shot and killed. They had both decided to try to quite without much success. After Lenoard's death, Bud never touched another drop of alcohol the rest of his life.

Notes for Sarah Jane (Sallie) Bryant:

• After Cornelious died Oscar took care of Sallie. When Oscar went to California she moved in with Ora and her husband until her death.

Sallie went to live with her daughter, Ora, until her death.

Notes for Ora Cranford:

Notes for William Calvin Fowler:

- He built school's in Ryker, Arkansas and Sedan, Kansas named the "Fowler School". He was the first clerk in July 31, 1879 and his brother Bennett taught in 1881 through 1888 and was clerk in 1884 1886- 1887. W.C.'s children had to walk 8 miles to school before the Fowler school was built.
- W.C. went west to avoid the Civil War draft. He fought and hated Indians instead because they took his horse and left him afoot. Some say he was part Indian, but he didn't claim it.
- W.C. Also supplied the land for the school at Ryker. He was the first to be buried at the Cave Mountain
- "Boxley". His grave is located on the east side in the middle of the cemetery. After settling on the 1g hill in Boxley, Nancy said, "Like a butterfly fluttering from flower to flower, he landed on a pile of manure". She knew what she was talking about because after his death she had to raise her children on that hill.[fowler.ftw]
- One researcher says that William Calvin went west to avoid the civil war draft. (Allred says that he was a Civil war Veteran???) But he fought and hated Indians instead. They took his horse and left him on foot. He was suppose to be part Indian but he wouldn't claim it. "The only good Indian was a dead Indian in his book," according to Wilbur Robertson.
- William Calvin Fowler built a school in Ryker, AR. The land was donated to him. He was the first person to be buried in the Cave MT Cemetery at Boxley. - In the book "Old Folks Talking" by Jim Liles the Fowlers appear to have arrived in the Buffalo River region of the Arkansas Ozarks after the Civil War. William Calvin Fowler was listed on the 1870 census with a wife and three young children, living near the "Boston Post Office" in Newton County. Arkansas between the Buffalo and Kings Rivers, about 15 miles southwest of the Big Buffalo Valley. He had come to Arkansas from McDonald County, Missouri.[Vilines.ftw]

- After W.C died she and the children applied for enrollment with the Cherokee Nation through the Guion Miller Rolls through her grandfather "Joseph Field" but they were ultimately rejected. All of them were living in Eufaula, Western District Indian Territory at the time of their application on July 26, 1910. Research tells me that they simply filed too late.
- According to a personal interview with Bill Fowler December 11, 1995, in the family Bible of Bill and Nina Lee Fowler the Field's family in east Tennessee were related to John Sevier, the first Govenor of Tennessee. *John Sevier was the uncle of Nancy (Lankaster)Lancaster, the wife of Beeson Fields.

- Ambrose fought and died in the Civil War as did some of his brothers. He enlisted September 9, 1861 at the age of 34 in Montgomery County, North Carolina. He was a Private in K Co. 34th Inf. Company K--Montgomery County--Captain, David R. Cochran. The regiment was organized at High Point, on 26 October, 1861
- Nettie Cranford Fowler told me when I was a child that of Ambrose and his brothers "One 'fit' for the North and the other 'fit' for the South,". There has been no evidence to date to prove that any of the Cranford's fought for the North. Ambrose is buried beside James and Ruth Riley Cranford. John Cranford, a brother, lies beside Ambrose.
- Clint Fowler said, Ambrose was 5' 8" tall and weighted 280 lbs. He was a farmer. The information that we have on the family and children comes from the 1860 Montgomery Co., Census Report. Harris Cranford had a son, Rex Cranford who has a daughter, Lucy, that still lives in Troy, North Carolina. The elder Cranford's are buried in the Lovejoy Cemetery and at the New Hope Cemetery near the "old Cranford home place" in Troy.

- Answer to confusion about Ambrose and the possible name of Larry or Lawrence as a first name
 of Ambrose. And who is that on the 1850 census in Montgomery County, NC in Richard
 Cranford's household that the writing looks like Larry or Sarry A. When all else fails look at the
 estate record:
- The story goes like this, in 1997 an aquaintance and descendant of Angus D. Cranford son of Richard that lives in the state of Wyoming asked me to copy for him my next trip to the NC Archives the complete estate record for Richard Cranford that died in Montgomery County, NC 1862. I did and mailed to him. Cost for mailing and copies was \$22.00. He paid. I also copied a few of the petitions that indicated the heirs and kept for my records. Later he sent me a typed

copy of one of the key petitions. I didn't have a copy of that particular petition but basicly it appeared correct and had no reason to doubt it being an exact duplicate of the original. I've used it quit a bit, so I'm in a big mess if it's not right.

- An estate record can be used to verify a census and in most cases somewhere in there will be an accurate recorde of the children or heirs of the deceased. In the case of Richard's estate and 1850 census this may set the record straight:

- Now look at the above list of defendants and compare to the below 1850 Richard census, looks

like Sarah Jane Cranford is the one in question on the census. And I'm not sure I can accept that looking at the original census record. It is written over and underneath it looks as could be Sara A. or as Cathy said Larry A.

- But it's obvious on the estate record we're talking about Ambrose being Ambrose and Sara A or Larry indicated as a female really being the estate record child of Richard indicated as Sarah Jane Cranford Beaman in the title case and as Jane Beaman in most other indications on the estate. And I'll vote for that.
- There is a marriage record in Montgomery County, NC for Robert Beaman to Jane Cranford on Aug. 7, 1851.

- Mr. Edison Curtis, or similiar, who lives in Salisbury, NC.
- Mr. Curtis is directly related to the Ambrose Cranford line, as I am to James Madison Cranford, a brother of Ambrose. Mr. Curtis has done a bit of research on the Cranfords in the Civil War, and has a file in memory of Ambrose at the Rowan County Library in Salisbury, NC.Mr. Curtis also is a volunteer in the genealogy room there from time to time.

- Also see as Catherine Hurley.
- Oral history says that she died 3 days after Bud was born, and his grandmother raised him. BUT: Caroline is listed on the 1860 census with Ambrose Cranford on the Montgomery County, NC census. She could have died in child birthing but it would have been after 1860. And a Neil is on there at age four. That is our Cornelious. Also listed are Harris age 9, Elizabeth M. age 7 and Nancy age 5. There is an estate record on Ambrose and it just indicates the sale of land and Caroline the executrix, not the heirs. Other of the deceased sons are the same as I recall. I take it if your Neil was listed as an heir and there was money left after expenses and such then he did receive something. (Donald P. Cranford researcher).
- Mrs. C. Olin Reeves of Troy, in Pike County, Alabama; and from Ed Hurley of Fern Park, Florida. Both of them; perhaps from the same source; indicated that Elias, William, Green and Winchop Hurley were sons of Cornelius Hurley (1795), of Montgomery County, North Carolina. Note: The author of this book believes that these boys were sons of "Accy Hurley", It appears that Accy was the father of at least seven children, and perhaps as many as ten.
- At the old Zoar Cemetery there is a Col. Aaron H. Sanders B.1802 D.1885 Married twice to Celia and Rebecca. Samuel Hurley B.1809 D.1872 Wife Elizabeth B.1831 D.1857 Daughter of Jerry Johnson.
- The only mention of Ambrose Cranford: In the Archives at Raleigh, there is a bond of George Coggins, administrator, dated July 5, 1863, with reference made to the dower rights of Prudence E. Hurley, the widow, and two minor children. The real estate is there described as 150 acres of land adjoining lands of Joshua Hurley, Ambrose Cranford, George Luther and William Burney.
- This folder file contains papers also as to the estate of a second Daniel Hurley, which should not be confused with this subject. That Daniel, born c. 1810/17, was a son of Stephen Hurley (1782). The files have been combined for no apparent reason, except the common name.
- From the records, it appears that the wife of our subject was Elizabeth Prudence Coggins, and that they had at least two children:
 - a. George L. Hurley, born 1861 to 1863

16. Joseph "Solomon" Fowler, born May 09, 1806 in Alabama; died January 11, 1888 in Chautauqua Springs, Kansas. He was the son of **32. Hiram Fowler** and **33. Elizabeth**. He married **17. Elizabeth R. Low(e)ry** Bet. 1828 - 1829 in Bedford County (?), Tennessee.

17. Elizabeth R. Low(e)ry, born May 10, 1810 in Bedford County, Tennessee; died August 18, 1892 in Tryon, Lincoln County, OK *Buried in the City Cemetery. She was the daughter of **34. Capt. Adam Lowry** and **35. Elizabeth**.

Notes for Joseph "Solomon" Fowler:

- Speculation: Solomon was named after his Uncle Joseph Fowler who lived in Hardeman County near Bolivar and built a ferry on the river in the early 1820's. Hiram must have moved to McNairy for some reason. (Possibly remarriage?) Solomon and Hiram are quite a bit older (in their 20's) than Sevier (who was only 6 years old in 1830.
- Solomon Fowler and Elizabeth Lowery left Tennessee, went to Arkansas, moved to Texas, and then to Kansas. According to information received in May 1973, a narrative history of the Fowler's from Zora Gladys (Fowler) Schmahl of Oklahoma City, OK. Her father, Bennett Webster Fowler, son of Solomon & Elizabeth, as told to her by her father in the summer of 1940 when he was 90 years old.
- Gladys states that, "Grandfather (Hiram Fowler) was a blacksmith in Bolivar, Tennessee. The family came from South Carolina to Mississippi, and to Tennessee. Solomon moved to Arkansas about 1847 where Bennett Webster and John Madison Fowler were born.
- They were in Pope County, Arkansas 1850 census dated 10/21/1850, page 506 or 254, family 191.
- (The census states that Solomon was 44, Elizabeth was 40, Teresa L. was 15, Martha M. was 11, William C. was 9, Mary E. was 6, John M. was 3, Bennet W. was 3 and 1/2. It also says that Solomon was from South Carolina and that Elizabeth was from Tennessee. No township listed. On this same census Sevier C. Fowler is listed as being age 26, Catherine 19, John 2, and Mary 2/12. Sevier is listed as being from Alabama and Catherine is listed as being from Tennessee. They are in King's River Twp in Madison County. The other Fowler listed twice in Pope County is James P. Fowler age 25 from SC. Listed once with wife, Emeline age 22 from North Carolina, Second James P. is listed with Mary E. age 22 from North Carolina (no Twp listed).
- The family then moved to Dallas County, Texas in 1852. At that time, Birdsville and Dallas were fussing over which would be the county seat. Afterwards they moved to Tarrant County, about 20 miles NW of present day Ft. Worth. The family lived on the west fork of the Trinity River on Walnut Creek. This land, 320 Acres, was taken away from them by the courts of Texas on the grounds that it was an old Spanish claim. Bennett Webster believed that the court held against them because his father, Solomon was a UNION sympathizer in the Civil War. She wrote that from what her father told her, "The family lived in Texas until about 1865 and that they lived in Missouri from about 1865 until 1870".
- Allred: "I have heard both my father and Aunt Jane talk about the war in Texas. They said that they moved to Denison, Texas to Ft Smith, Arkansas and from there to McDonald County, Missouri. They lived in Missouri from 1870 to 1873 and then went to Prairie City, in what was

the Cherokee Nation. It was located 20 miles NW of Vinita, 15 miles SW of Seneca, Missouri, and about 20 miles SE of Baxter Springs, Kansas. There Solomon farmed, blacksmithed, and raised cattle. He leased lots of land from the Indians. His last move was to near Sedan, Kansas where he died. Solomon willed the bulk of his estate (160 acres) to his son Marion Park Fowler".

- Jim Allred did some more homework on why Solomon gave this land to Marion Park Fowler. "I ran across a note that Solomon had land in Oklahoma that he had sold. It was customary under the 1862 Homestead Act for the father to apply for land for dependent males. The Homestead Act gives 160 acres of western land free to any US citizen. It could be quite possible that it was Marion Park Fowler's land. He was only 6 years old when the Act passed. This may be why John Madison and Bennett Webster had land in Oklahoma as well. John Madison was a witness to the writing of Solomon's will."
- The 1880 census of Chautauqua County, Bellville, Kansas (page 7, Ed66, Sup Dr#2-296, family 65-line 40) finds them living with daughter Miranda Jane Wood and her son Andrew S. Wood age 12, Andrew's father born in Georgia). Solomon was 74 and Elizabeth was 69 then. Marion Park Fowler, age 24, was living with them. Solomon indicates that he was born in South Carolina and his father was born in North Carolina and his mother was born in Virginia. Elizabeth Lowery Fowler indicates that she was born in Tennessee and that her father was born in Tennessee and her mother was born in South Carolina. Andrew S. Wood said that he was born in Georgia.
- Some of the family have recently replaced Solomon's headstone and changed the year of the date of his death. There is some investigation as to why this date was changed.

- 1820 Bedford County Census:
 - o Rebecca Fowler # 8: 2m(16-18), 2m(16-26), 1m(26-45) 1m(over 45), 2f(16-26).

 - o William Fowler #14: 3m(under 10), 2m(10-16), 3m(16-26), 1m(over 45).
 - o Joseph Lowry #13: 2m(under 10), 1m(16-18), 1m)26-45), 2f(under 10), 1f(16-26).
- Elizabeth's mother lived until she was 105 and her father was said to have been a Captain in the War of 1812. Elizabeth was living with her son, John Madison Fowler, when she passed away. She is not mentioned in her husband, Solomon's Last Will and Testament. All that he had went to their youngest son, Park. The other's received one dollar each.
- Elizabeth Lowery's sister, Matilda married Bennett Burleson of Denton, Texas. Bennett Webster is named for him. She came from east Tennessee.
- Elizabeth is buried on the old John Madison Fowler home place in Tyron, Oklahoma.
- In 1835 Cherokee Census compiled by Homer A. Walker (Chicago Library), there were several Lowery's listed. Solly and Arch are named in Hamilton County, Tennessee. In a book "Fowler's Arithmetic Tennessee Cousins" by Worth S. Ray, Genealogical Publishing Co. 1960 (found in Pineville, MO Library Ray County, Missouri settled by Cocke County Tennessee families), mentions that on February 27, 1819, the Hiwassee Purchase was signed by Cherokee Chieftains, one of whom was George Lowery. It also mentions that from Monroe County Josiah Fowler, brother of Abijah Fowler moved to Texas before the Civil War. Also in Hardeman County, it mentions that during the 1820 Joseph Solomon Fowler built a cabin and ferry about 16 miles south of where Bolivar was afterwards located. It was named "Lowery's Ferry". (It was changed to Niles whenever the book was written in the 1800s in Monroe County, Tennessee.) It also mentions that Abijah Fowler, son of Dr. Thorn Fowler "school teacher" married Elizabeth Curtian, daughter of Richard Curtain and they lived in Cocke County (Older Son 1842 William).
- One of the biggest frustrations is that many ancestors eventually dropped their first names and went by their middle name...and every brother and sister named their children after their brother's and sister's.
- The "Fowler Arithmetic" also has a note from White County, Tennessee, that John Lowery would

have been Govenor of Texas had he not been in poor health. Jim Lowry was a prominent newspaper man in Texas. Both were son's of Alexander Lowery who laid out the town of Sparta in western Tennessee. Also in Henry County, TN indicated that on Feb. 28, 1848, Arthur Lowery married Nancy A. Coleman and on the same page 781, William J. Fowler married C.H. Duncan on August 1, 1856. The first Govenor's of Tennessee was named John Sevier, who married a full-blooded Cherokee Indian named Elizabeth Lowry. Gladys indicated that in "Anserchin News", Vol. 1-9 marriage bonds on page 77 showed Shelby County, Tenn. Vol. 1 Isaac Lowery to Susan W. Lowery Dec. 16, 1841. John R. Lowry, Sec., Vol. 2 to Mary Wilcox, Feb. 1, 1824. Joseph Rhea, Sec., A.B. Carr., J.P. Page 97, Bedford County, TN Tax List 1812 shows Greenbury Lowry #43, Captain's Company - John Roberts.

• Gladys also found where an Elizabeth Lowry transferred or sold 70 acres of land to Thomas Cummings in 1834 or 36. (This would have been about the time the Elizabeth was marrying Solomon. She inherited this land from her father, David Lowry who made the Will in 1814. James B. Lowry bought 126 acres in 1839 in the same area and a joining her land. The Lowry's were storekeepers and lawyers in east Tennessee.

- In 1870 Census of Eureka, Greenwood, Kansas, page 2, line 16 dated July 15, 1870, shows John M. Fowler as the 9th family listed. He was age 23 and Catherine was 21. Family #11 was Joshua Kinnamon age 53 born in Virginia, and wife Susan A. age 53 born in Tennessee. Family #12 was Byron Kinnamon, age 22, born in Illinois, wife Melissa, age 21, Ella, age 2, and James 1/2 both born in Kansas.
- John Madison Fowler served in the Kansas Volunteer Infantry. They were Baptists for a while and then joined the Church of Christ; some member's of the family were member's of the Disciples of Christ. After the war ended and after Catherine lost her health and died, John married Miss Effie Ellen Smith. Effie was several years younger than John and they started a second family.

Tax list shows Nathan Ward living on Saddle Creek with 236 acres, a house 24' x 18', valued at \$350, Stephen Ward, living on Saddle Creek, with 50 acres, and having one "cabben", Thomas Ward (living in what is now Carroll Co. -- connection unknown). and Wells Ward, (jr) on Saddle Creek, with 50 acres and "cabben" and inferior grist mill, valued at \$100.
- Nathan (B. ca. 1761-D. 1803+) was one of the sons of Wells Ward, Sr., His children were named: Benjamin, Zachariah, Eleanor, Lewis, William, Enoch, Wells, and Nathan, Jr. Wells of this group migrated to Indiana and Nathan, Jr. moved to TN in 1822..

Notes for Angus Donahue Cranford:

- 4th Inf. Company F North Carolina Confederate Army (A.D. Cranford) They went to Indiana with Riley Cranford and his family.
- In discusion's with descendants of Angus Donahue Cranford a brother of Ambrose that died in a New York Yankee Prison Camp. They indicated that descendants of Angus on part of the land sales didn't receive anything as he had been given land before the war and this was deducted. The widow and children of Angus left these parts and moved to Indiana after 1865 I've been told. Though I'm not aquainted with the facts, I do recall that one other son of Richard rec'd land prior to the war and his heirs didn't get anything from the sale of that land, but from sale of other land. I have no details of this as this mostly related to me from verbal contacts. Donald P. Cranford genealogist and researcher.

Notes for Linna Ann Hulin:

- The 1860 Montgomery County, NC census shows 5 children. Linna Ann Hulin's family were Quakers and may have been what got her into trouble with the Cranford succession (after Angus D Cranford was killed in the Civil War) and this cost her the farm. Her mother in law (Elizabeth) took all of their possessions. Linna's brother's wouldn't fight for the Confederacy and hid out until two of them were hung. The home guard did the deed and these brothers are buried in Lovejoy in Montgomery County North Carolina.

Notes for Cornelious Hurley:

- Cornelious (Neil) Hurley lived in the upper northwest section of the county, was not a robust man, and died of what was then called consumption. He appears as head of household in the census records of 1830,1840, and 1850 for Montgomery County, with various members of his family. The 1850 census, the first to do so, gives the names and attained ages of Cornelius, his wife Elizabeth, and eight of their children.
- Three of the children were not living at home during the taking of the 1850 census, but are known to us, and will be reported further.
- The family of Cornelius is perhaps more accurately documented from recent knowledge. He was the father of as many as thirteen children, all of them born in Montgomery , N. C., based on census and other information:

- "The Alabama families state that their Daniel was called "Shad". Strangely enough, our records indicate that one of "our" Daniel's sons, Joshua, was nicknamed "Shad"! They list one of his sons as being Freeman Hurley, who moved to Alabama. One of our Daniel's sons, Daniel Wade (1810), WHO could have been one of the brothers of Freeman, named one of his own sons West Freeman Hurley (1842); FOR HIS BROTHER, perhaps?
- There is a problem, though, with the rest of the information received from Alabama, relative to the reported children of Cornelius Hurley and Daniel Hurley. They report a son Tom born to Daniel Wade.
- and we are not aware of one by that name. As to Cornelius, they report sons Elias, William, Green and Winchop. Our Cornelius had no such sons that we know of.
- However, in the records of Chatham County, N. C. we have found the family of Accy Hurley, born 1794 to 1802, about the same time frame as Cornelius (1796), son of Daniel (1771). Accy Hurley was a son of Amos Hurley (1755) and had four sons: Elias Wesley, Greene, and Winship. It appears probable that a mistake has been made by our Alabama cousins in assigning the sons of Accy Hurley to Cornelius. We believe then, that Daniel and his wife Mary Worrell were parents of the following children:

This folder file contains papers also as to the estate of a second Daniel Hurley, which should not be confused with this subject. That Daniel, born c. 1810/17, was a son of Stephen Hurley (1782). The files have been combined for no apparent reason, except the common name. From the records, it appears that the wife of our subject was Elizabeth Prudence Coggins, and that they had at least two children:

- An inquiry I made for McNairy County regarding Occupant/Revolutionary War Land Grants came up with two Lowery/Lowry names there:
- Adams Lowry 98 acres in 9th district 3rd range and 6th section John D. Lowry 25 acres in 9th district range 3 and section 6.

- When I asked where the 9th district was, I was told that it was all of McNairy County. When I asked where the 3rd range and 6th section was, I was told that it might be part of Chester County now. In 1882 Chester County was formed out of Henderson, McNairy, Hardeman Counties.
- During the 1830, "Lowry's" listed were Robert (age 20-25), Robert B.(age 60-70), and Adam (40-50). Based on the children and ages listed with each, I have concluded that Adam Lowry is the most likely father of my line. Males: 2 (up to 5); 2 (10-15); 1 (40-50); Females: 1 (5 to 10); 1 (10 to 15); 1 (15 to 20)[most likely Matilda]; 1 (30 to 40). Since this is a recent conclusion, I have yet to verify this.

When I asked where the 9th district was, I was told that it was all of McNairy County. When I asked where the 3rd range and 6th section was, I was told that it might be part of Chester County now. In 1882 Chester County was formed out of Henderson, McNairy, Hardeman Counties.
- During the 1830, "Lowry's" listed were Robert (age 20-25), Robert B.(age 60-70), and Adam (40-50). Based on the children and ages listed with each, I have concluded that Adam Lowry is the most likely father of my line. Males: 2 (up to 5); 2 (10-15); 1 (40-50); Females: 1 (5 to 10); 1 (10 to 15); 1 (15 to 20)[most likely Matilda]; 1 (30 to 40). Since this is a recent conclusion, I have yet to verify this.

M. could be James Madison Cranford and that's why I did this research years ago as numerous people were asking about that. When I looked at the 1862 estate record for James Madison Cranford that made it all fall in place.

- A noted Cherokee chief, recognized by the British government as the head chief or "Emperor" of the Nation, about 1760 and later, and commonly known to the whites as the Little Carpenter (Little Cornplanter, by mistake, in Haywood). The name is frequently spelled Atta-kulla-kulla, Ata-kullakulla or Ata-culculla. It may be rendered "Leaning wood," from ata , "Wood" and gul kalu, a verb implying that something long is leaning, without sufficient support, against some other object; it has no first person form. Bartram describes him as "A man of remarkably small stature, slender and of a delicate frame, the only instance I saw in the Nation; but he is a man of superior abilities."
- Three of seven young Cherokees, who were escorted by Sir Alexander Cuming to England in 1730 to meet King George II. The Cherokees signed articles of friendship and commerce with representatives of the British Crown. One of the Cherokees was Oukanaekah, later named Attakullaculla or the Little Carpenter.

In 1758 Attakullaculla wrote Littleton, "I desire that you would send me a cloak for my wife," and once he tried to exchange two prisoners for two Negro slaves to help her. In November, 1774 she accompanied him to North Carolina. In Bethabara husband and wife listened to the peal of the organ. He had heard many organs but she insisted that the lid be removed for she feared a child was trapped inside. In a letter dated 1766 she is mentioned, but nothing more. (Journal of Cherokee Studies, Vol. III, No. 1, Winter, 1978 p. 27)

Finally the whole country, which the Tsalagi (Cherokees) and their fathers have so long occupied, will be demanded, and the remnant of the Ani Yvwiya, The Real People, once so great and formidable, will be compelled to seek refuge in some distant wilderness. There they will be permitted to stay only a short while, until they again behold the advancing banners of the same greedy host. Not being able to point out any further retreat for the miserable Tsalagi (Cherokees), the extinction of the whole race will be proclaimed. Should we not therefore run all risks, and incur all consequences, rather than to submit to further loss of our country? Such treaties may be alright for men who are too old to hunt or fight. As for me, I have my young warriors about me. We will hold our land."
 - o [The Indigenous Peoples: "Indians" in North America before the European Invasion through the 19th century.] Subsequently the Henderson Purchase was repudiated and negated by both British and American governments. individuals were not allowed to make land purchases. that right was withheld by centralized european governments dealing with tribes as nation-to-nation.
 - o 1792 February 17; Chickamauga Chief Glass and Dragging Canoe's brother, Turtle At

Home, waylaid the John Collingsworth family near Nashville, killing the father, mother, and a daughter, and capturing an eight-year-old girl. Returning to Lookout Town (near Trenton, Georgia), they held a scalp dance, grinding one of the scalps in his teeth as he performed. Dragging Canoe, recently returned from Mississippi after meeting with Choctaws, celebrated the occasion so strenuously that he died the following morning, age ±54.

After several years in Texas, he moved to the Indian Territory where he continued raids against the Osage.
- o While the Cherokees were in Mexico, The Imperial Mexican Government of Iturbide was

overthrown. In June 1823, the new government informed the Cherokees to return to Texas and no more Cherokees would be allowed to migrate to Mexico. To mollify the Indians, Chief Diwali was made a Lieutenant Colonel in the Mexican Army and appointed as Administrator for all of the Indians in East Texas. Peter Ellis Bean was appointed by the Mexican Government to be Indian Agent for East Texas.

O Upon Fields' return to Texas, he started making an alliance with all Indian tribes in East Texas, urging those in the United States to join him. This excited the Mexican Government on the intentions of the Cherokees, and the government tried to counter the Cherokee influence with other Indians. A great Cherokee War Chief Tahchee, also known as Dutch, left the Cherokees in Arkansas and crossed the Red River into Texas in 1827. Tahchee and his warriors lived for fighting - anyone, but preferably the Osage Indians.

Then the 100 year old Mary Cranford found in Montgomery County in 1850 and believed to be his wife by a lot of people may have been the only one he had. She could fit the case. This more than likely Mary Hopkins. But one branch of the family, Sarah Cranford that Samuel Tolbert indicates a Mary Hill. This could be as there is a Mary Hill daughter of a Rachel Hopkins Hill that we have never found who this Mary Hill married. This Rachel Hopkins and Mary Hopkins believed to be descendants of Gerard and Margaret Johns Hopkins. A Quaker family from Maryland. Also a hundred or so years later their descendant was Johns Hopkins connected to that famous Baltimore hospital and in that family there must have been 20 Johns Hopkins in different branches of the family. Try and figure that out.
- In short there are enough incomplete records to really confuse the issue. And not enough of other records to sort the fact from fiction. I tend to lean to the one wife named Mary Hopkins belief but have never found a document that says that.

Have had a couple of private e-mails that indicated the month of death they had was April 1830. The info in the Fayettville Observer as appeard in the book under the May 13th 1830 issue of that paper and on page 43 of the book and indicated old Leonard died on the 13th; this could be interpreted as he died on May 13, 1830.
- Also other newspaper indications of this death notice do this. The original information came from the May 4th 1830 issue of the Western Carolinian published in Salisbury, Rowan Co., NC:
- Died In Montgomery county, near the narrows, on the 13th ult. after an illness of nearly two years duration, Mr. Leonard Cranford, between 80 and 90 years of age, leaving a wife and five small children.
- Since the 13th had not yet passed when this issue of the paper published then the month of death had to be April and I have recorded as the death date for this Leonard Cranford April 13, 1830 and this Western Carolinian death notice as the source. This also establish's his about birth year as 1740-1750. What we have done is split the difference and is indicated as born about 1745 and this notice is also used as the source.
- The place of birth is not indicated here and comes from family info sources and is believed to be Maryland. Leonard is first found in NC on the 1779 tax list in Randolph County. Later on the 1790 census is found in Montgomery County, NC.
