In obedience to said order the heirs proceeded to make partition and division accordingly and now submitted to the court this their report. but before (Page 407) they proceeded with the details connected with the division, it is deemed proper for a clear understanding of the facts of the case to premise that the said James Little left at the time of his death nine children and heirs at law, to wit, Caroline C. (the wife of T.E. Babb) Malinda C. (now the wife of Alexander Stewart) James Little Jr., Nancy A. (now the wife of Nester Fort) Samuel R. Little, Ambrose H. Little, Ewing M. Little, John D. Little and William G. Little. Six of these heirs, to wit, the said James Nancy A., Samuel R., Ambrose H., Ewing M. and William G. was minors under the age of twenty one years for whom your honorable court appointed P. R. Smith as their guardian who accepted the appointed and took upon himself the duties thereof, sence which time the said James Little has arrived at full age and the said Nancy A. has married and the said William G. has departed this life so that the said guardianship of

of the said P. R. Smith has ceased except as to the said Samuel R., Ambrose H., and Ewing M. The under-signed would also promise that after the appointment of said Smith as such guardian by order of your honorable caurt a division and partition was had of certain slaves belonging to the estate of the said James Little deceased amongst the heirs to said estate by which the said Babb and wife, Stewart and wife and John D. Little secured their full shares of said slaves and the said P, R. Smith in right of his said wards received two negro women, to wit, one name Jane and the other name Eliza as their interests on said slaves. Since which time the said Jane has gave birth to a child name Jim and the said Eliza has given birth to two children one name Jo and other name Ellen

Thus it appears that the two negros which were alloted to the minor heirs and secured by the said Smith as their guardion now number five. Since the division of the slaves already referred to, the said William has died without issue father or mother and consequently his said brothers and sisters inherit his affects including his interests in the slaves of the estate of the James Little deceased. The said John D, Little has also died leaving a daughter Kiziah his sole heir at law, who is an infant and for whom your honorable court has appointed Permelia Little as guardian.

So it appears, and so the undersigned have agreed, that the said Fort and wife, James, Samuel R., Ambrose H., and Ewing M, are each entitled to the one sixth part of the value of said five nagroes, leaving the intense of the said William now deceased in and to said five negroes (which was one sixth part also) to be equally divided amongst the seven surviving heirs, to the estate of the said James Little deceased,

and the said Keziah who is entitled in right of her deceased father John D. Little and whose intenest is just equal to the other heirs to the estate of the said William G. The several and respective rites and interests of each of said heirs being thus assertained and agreed upon, The undersigned next proceeded to assertain and agree upon the value of the said five slaves so that a decision thereof might be made in the manner specified in the order of your honorable court and in doing so it was agree that the said negra woman Jane and her child Jim are worth one thousand and fifty dollare and that the woman Eliza and her two children Jo and Ellen are worth twelve hundred and fifty dollars making the total value of said five negroes the sum of \$2,300. It is deemed proper to notice in this connection that since the said Smith had had said women in his possession he has received for their hire yet unaccunted for the sum of \$101, which added to the total value of said negroes makes the sum \$2401 and also since said negroes has been under the charges of Smith he has been necessarily compelled to expend on their account the sum of \$8.10 by way of tax for the years 1851 & 2 and also the sum of \$6. for medical bill. He is also entitled as conceived and as we have agreed to the sum of \$135 for percentum as guardian and to the further sum of \$11.26 for other cost connected with his guardianship which make when added to \$6.43 over paid in Smiths last settlement with the court make the sum of \$166.79 which we conceive to be proper and so we have agreed to deduct from the total value of said slaves and the hirs of the two women which the net sum of \$2,234.21 to be distributed among the several heirs as directed. It is further agreed and understood by and between said heirs that the said Mister Fort has bought for a

good and valuable consideration the entire shares and interest in and to said five negroes of the said Babb and wife, Stewart and wife and the said James Little for which when added to the intense of himself and wife make the sum of \$911,66 to which he is entitled and upon the division of said negroes it is agreed that the said Fort may take the women Jane and her child Jim at their estimated value upon his paying to the said P. R. Smith in right of his said wards and said infant heir of said John D. Little deceased the sum of \$138.34 (Page 409) which added to the value of the said woman Eliza and her two children

(which areestimated at the sum of \$1250.) make the sum of \$1322.55 which said Smith is to pay said Permelia Little in sight of her said ward the sum of \$41.73 it is proper to mention a claim in favor of the estate of John D. Little deceased against the estate of the said William G, deceased amounting to the sum of \$38.50 was deducted from the share of the said William F, before a decision thereof was made which reduced the same to the sum of \$333.87. It is also necessary to state that said Smith owe of the amount of the value of said slave and said sum of money is to pay to the Estate of John D, Little deceased said claim of \$38.50 which together with the sum of \$41.73 when taken from the value of said woman Eliza and her two children and the amount of money so to be paid by the said Fort to said Smith being in the hand of said Smith the sum of \$1,242.30 the amount which we ascertain to constitute the share of his said wards Smauel R., Ambrose H. and Ewing M. and it agreed that said Smith shall on account of his said words take the said woman Eliza and her two children at the price of \$1250 agreed upon as above shown.

I am glad to know that the first state warrant for \$150.00 has been sent to you under the terms of the Raney bill which it was my pleasure to get passed through the last session of the Legislature, and which law I tried for two years to get adopted.

It is indeed gratifying to know that the great State of Arkansas is to pay you at least an amount that will help to make the sunset of your life one of ease and plenty. It is regrettable that more has not been done for you years ago.

The law which I passed provided that you receive \$50.00 a month the rest of your life, payable each month, but I understand you will be paid quarterly, or every three months, so you will receive a warrant for \$150.00 every three months hereafter which equals \$50.00 a month.

I will be at the Annual Reunion for the Confederate Veterans which will be held in Little Rock next May. I hope it will be convenient for you to attend and I will be delighted to have the pleasure of meeting you there. Should you ever come to McCrory or Woodruff county at any time, I will be glad to have you pay me a visit either in my newspaper office or in my home. You will always find the "latch string" on the outside for you and yours.

I am glad to know that arrangements are now being made to send you your next warrant for \$150.00 on or about December 1st and you should get it sometime the first part of December, at least before Christmas, so that you will have it for Christmas time which I hope will be the happiest you have experienced for many years. Then in March, next year, and every three months thereafter you will get another warrant for \$150.00, making the total amount of your pension \$600.00 a year, or \$50.00 a month.

Assuring you that it was the greatest pleasure of my life to get this increase for you and your fellow pensioners. and if at any time I can serve you personally or through the colums of my newspaper, The Arkansas Central Leader, of which I am editor and publisher, please don't fail to call on me. With best wishes for you and yours, and hoping you will live many more years to enjoy your pension, I am,

In recent years a good many pepole have gone to Californis, and Oregon" From Arkansas, One might think that this was a modern Develoment made possible by the Automobile and paved road but they was no paved roads in that day and time in 1868 there have always been a few daring adventurous souls in every Coummunity, it was said they traveled in best movie wagon train style Driving their wagon into circle, at night, with the tongues toward the center, inside the circle and fires were built mealt cooked, and bed rolls spread out, and some of the men formed a Guard" Told by the wagon master, or Captain, of the train" which always watched both the wagons and Teams. nothing would have suited some of the "Wild" Indians better than to have stolen the Mules and wagons, and Killed the Travelers, besides Inians, and Siskness was possible the most dreaded on the Oregon trail, meny persons died and were buried beside the trail, Usually a wooden board with the name of the deceased Carved on it with a Skinning Knife, and Doctors were a rarity in a Wagons, train,







Biography Malinda Catherin Hollis (Little) Goodspeed Memoirs of Northwest Arkansas

Mrs. Catherin Hollis. James Little (deceased) was born in Georgia in 1801. When a young man he immigrated to Clark County, Ark. and there married Nancy Gentry, a native of Nashville, Tenn., born in 1802, who came with her parents to Clark County. After his marriage Mr. Little moved to Washington County, in 1828, and engaged in farming and stock raising. He was left a widower in 1840, with four sons and three daughters. He then married Elizabeth Franklin, who bore him two sons. He was a democrat, and in religion was a Primitive Baptist, as was his first wife. Mrs. Little is still living, and is a Methodist. The death of Mr. Little occurred in 1844 and was much mourned by his friends and acquaintances. Catherin was the fourth child, one of his first wife's children, and the widow of the highly esteemed Luther N. Hollis, was born October 10,1825, in Clark County, Ark. She was there united in marriage in 1848, to Alex. A. Steward, who was born in Indiana in 1820. Mr. Steward came to Arkansas when a boy, and had been previously wedded to Ester Hinds, who lived but a short time. Mr. Steward was a shrewd business man, second lieutenant in the Mexican War, and a Democrat. He died in 1853. The following year his widow married Luther N. Hollis, who was born in Indiana in 1826. Having learned the tanner's trade when a boy he worked at that business in Cinncinnati, Ohio, Cassville, Mo. and Fayetteville, Ark. Later in life he turned his attention to farming. He also served in the Mexican War, and upon the outbreaking of the Rebellion enlisted in the first Confederate company- Capt. Carroll's-that left Crawford County, serving as first lieutenant until the close of the war. He was twice taken prisoner and twice released. He died in 1877, lamented as a kind-hearted neighbor, loving father and faithful friend. Mrs. Hollis has but one living child, Miss Luther Maud Lee, who was born June 14,1865, but she has cared for an orphan boy, Dick Hollis, who lives upon the farm. Mrs Hollis owns 357 acres of land besides town property.

Dear Lillie,

Please forgive me for not writing much sooner! We were in Russia for a month in May and I am involved in writing a textbook on ancient-mediev history which is due to be published next March. I had to make an unexpected trip to New York in June and then over to Morgantown, West Virginia to bring our daughter home for her father's 65th birthday tomorrow. How I wish I could be with you all for the reunion, but as you can see, that is out of the question. Perhaps, next year?

Now to my side of the Little family. I am descended from Nancy Angie Little, daughter of James Little and Nancy Gentry. Nancy Angie was born in 1834 and married Nestor Forte or Fort who was 23 at the time on June 12,1851. He was from Crawford County and she from <u>ashington County</u>, Arkansas. I believe Nancy was the 6th child of James and Nancy Little - John, James, William, Martha Caroline, Malinda Catherine, Nancy Angeline and Samuel Rector Little. After Nancy Gentry Little died in 1840, James married Elizabeth Franklin in 1842 as you probably know.

I think Nestor Forte was born in Missouri. He supposedly died of a broken heart in 1865 or 1866 and she six months later. They had 5 children - Mary Ellen, Nancy Katherine, Caledonia Alice, Angeline and a baby who died of cholera. They are listed in the 1860 census in Leis Creek Township, Crawford County with #3000 in Real Estate and \$12,959 in personal property. Rumor has it that one of Nancy's brothers who took custody of the girls after their deaths absconded with the money! If true, all is forgiven!!!

Mary Ellen, born in 1852 in Crawford County married William Sterling Matlock (my Dad was named for him - if there are relatives there, please tell them I love them already!) They had one son Albert Mattlock born April 12,1880 in Stattler, Crawford County. He married Mina Wood and had 7 children - Joseph, Crystal, Goldie, Jeannette, Albert. Armstrong and Jack Pershing.

Nancy Catherine known as Katie was born in 1854 in Crawford County and married Joseph A. Kimbrough from Springfield, Missorui - at least he was born there. Is N.D.Kimbrough one of their children - thought there were 6 altogether. My Dad spoke of the Kimbroughs. I believe J.D. was born in 1875 and married Maud Mickel, the daughter of Dr. F.A. Mickel of Crawford County and they had 4 children - Melba, Jean, Lois and N.D.,Jr.

Angleine was bron in 1860 and married Richard S. Hollis (born 1857) on January 1,1880 in Washington County. They had one daughter, Dixie.

Alice Caledonia was born in 1858 and married James Washington Cooper, born May 7 or 8, 1842. They had 6 children:

Harry Stuart, both November 21,1881 in Eureka Springs, Arkansas, martied Ann Elizabeth Simpson on June 16, 1913. Harry died October 30, 1965 and Elizabeth (bign Janary 27,1884 at Savannah) died January 16, 1963. Both died at Savannah. They had three children: Ann Elizabth (March 31,1914) married Richard Arte Carter (January 11,1913 -July 1,1975). They married October 7,1933 and had one son Richard,Jr. He was born September 23,1934 and married first Margaret Grail Milligan. They had one daughter Margaret and he married on December 24,1960 Carolyn Elizabeth Epting and they have 7 children.

Inez, Harry and Elizabeth's second daughter, was born April 25,1919 and died February 19,1973 at Savannah. She married William Samuel Sullivan, born December 30,1916 and they adopted Patricia Diane, born November 12,1948.

Harry Stuart, Jr. was bron August 27,1920 in Sannah, married October 11,1942 to Mildred Elizbeth Stricland (born January 14,1921) and they had two daughters, Ann Elizabeth, born October 29,1948, and Susan Margarat, bron March 6,1954. Harry died September 17,1975, in Savannah of cancer.

Minnie Harriet Cooper, 2nd daughter of Alice Caledonia and James Washinton, was born May 21,1884 at Keithley, Butler County, Kansas and married Benito Moreno on November 5,1902. Their daughter died at birth. She married Thomas' Winn Wright (born July 12,1875) on December 25,1920 at El Paso, Texas. He died September 25, 1955 at Kingman Arizona. Hattie, as she was called, died January 2,1961 at Kingman.

Mary Etchel, thrid child of Alice Caledonia and James, was born January 15,1886 at Beaumont, Butler County, Kansas and married Henry Hast Holstein on September 20,1905 and they had one son, Henry, Jr., born about 1910 in Savannah. He never married and we have lost track of him.

William Sterling Cooper, my father, was the fifth child of Alice Caledonia and James. He was born on March 29,1889 in St. Louis and married Flora Johanna Oberg on July 6,1915 in St. Louis. He died February 6,1971 and she July 6,1975 in Cincinnati, I am the only child, born September 28,1921, married Robert Theodore Howe January 5, 1946 in Cincinnati. He was born July 4,1920. We have 3 children -Barbara, Nancy and Steve.

James Washington Cooper, Jr, the fourth child of Alice Caledonia and James was born December 16,1887. He married Lillie Braswell (born December 11,1888 at Uniontown, Arkansas) and they married May 26,1911 at Dripping Springs. James died March 15,1973 and she died September 15,1980 both in Oklahoma City. They had 6 children James William, Mary Ellen, Kirk Little, Harriet Virginia, Edward and Thomas Henry. I have all the information on them but will get it to you later.

Lillian Gabriella, the last child, was born June 14,1892 at Ellendale, Missorui and married Walter Leonard Muller on May 20,1913 (bron May 25,1887 at Savannah). They had one son, Walter, Jr., born January 26,1914 in Savannak Little Rock. He married Alma Schellenberger on June 14,1941. They have three children - Sue Elle, Janice and Walter, Jr. Walter, Sr. died June 24,1922 at Savannah and Lillian remarried Gus Hampson on August 9,1940 in Cincinnati. He died October 25,1955 and she died on September 27, 1963.
